# Vaccination Facts & Health Disparities

As you begin learning about best practices for making sure your employees are able to receive COVID-19 and flu vaccinations, it's important to understand impacts of these illnesses.

### Value of Vaccines for Certain Preventable Diseases



Vaccines have helped save lives for over 100 years<sup>1</sup>



Vaccines are one of the best ways to help protect yourself from certain vaccine-preventable diseases<sup>1</sup>



Vaccines can help prevent serious illness and potential serious complications<sup>1</sup>





COVID-19 can be very contagious and spread quickly, especially indoors. It can even spread if symptoms are not present<sup>2,3</sup>

# 6 Months+

The CDC recommends that everyone ages 6 months and older stay up-to-date with COVID-19 vaccinations<sup>4,5</sup>



According to a 2021 study, the estimated per-patient hospitalization cost related to COVID-19 was **\$21,889** among patients with a primary diagnosis of COVID-19<sup>6</sup>



The flu can be spread to others before any symptoms are present<sup>7</sup>

### Flu Facts



Flu vaccines have been shown to reduce illness and the risk of serious flu complications<sup>1</sup> 8%

According to a CDC study in 2018, about **8% of the U.S. population** gets sick from the flu each season. That's **more than 26 million people!**<sup>7</sup>



# Employees at High Risk for Severe COVID-19

Some people are more likely than others to get very sick if they get COVID-19.8

Certain risk factors for severe COVID-19 include<sup>8</sup>:

- Being 50 years of age or older<sup>9</sup>
- Being obese or overweight
- Being a current or former smoker
- Having diabetes
- Having heart conditions
- Having chronic lung diseases
- Having a weakened immune system

# Building Health Equity in the Workplace

There are many factors that create barriers to vaccination access and acceptance, and disproportionately affect racial and minority groups. Some of these factors include<sup>11</sup>:

- Gaps in healthcare access
- Lack of trust in the healthcare system due to historical factors
- Transportation conditions
  - Those who face geographical challenges to vaccination access and acceptance are more likely to get seriously ill due to the factors listed above



Promote trust and health equity within the workplace. By hosting a company vaccination clinic, you are letting all your employees know they are important to you. You'll build vaccine confidence, educate employees, raise awareness about COVID-19 and flu, and more.

# Protecting Employee Health Within Your Company

Facilitating vaccinations can help promote a healthier workplace, improve employee morale, and benefit your company's bottom line.

### Benefits of Employee Wellness

Hosting a clinic to help your employees get vaccinated shows that their personal health is important to you. This may include potential for:



**Reduced absences** due to sickness and doctors visits<sup>12</sup>



**Reduced costs** due to fewer absences, resulting in improved productivity<sup>12</sup>



**Improved morale** due to lack of absences and less individual workload<sup>12</sup>

# Employer Best Practices for Vaccination Clinics

Before you get started on planning your vaccination clinic, let's look at some important things to consider.

# Benefits of COVID-19 and Flu Clinics

So, why should you consider offering COVID-19 and flu vaccinations to employees during the same clinic?

$\checkmark$	COVID-19 vaccines can help protect your employees from getting
	seriously ill or being hospitalized with COVID-19 <sup>13</sup>

According to the CDC, eligible people may receive more than one vaccine during the same clinic visit.<sup>14</sup> Employees can ask their healthcare provider or pharmacist about the risks and benefits of getting more than one vaccine in the same clinic visit

# Adding Vaccination Clinics to Health Events

Consider integrating vaccination clinics into other health events scheduled for the fall and winter seasons. These include:

- Health fairs & wellness events
- Biometric screenings: health exams that include blood work & other measurements

# Timing: When to Hold Clinics

- Consider holding full-day clinics that last for at least 2 days or clinics that have multiple shifts
  - This can help give all your employees, whether they are hybrid or part-time, time to get vaccinated when it fits into their work schedule
- Hold clinics after mid-September and before the end of October to ensure inventory is available for COVID-19 and flu vaccines
  - By hosting clinics during the height of vaccination season, you can help your employees get their vaccines when it is top of mind

### Healthcare Coverage

 Vaccine-related reimbursement will depend on your employees' insurance plans, whether that's private/commercial, Medicare, or Medicaid<sup>15</sup>

### Vouchers for COVID-19 and Flu Vaccines at Off-Site Clinics

Consider providing vouchers for remote employees, those not covered by health insurance, or family members not covered by the employer benefits plan—so they can get vaccinated at a participating pharmacy

## Incentives Offered by Employers

When you begin to think about setting up your own vaccination clinic, incentivizing action can play a large role in influencing higher vaccination rates in the workplace. Consider offering incentives such as:



### **Monetary Incentives**

- \$0 out-of-pocket cost for recommended vaccinations
- Gift cards to local businesses



### **Non-monetary Incentives**

- Raffles with prizes
- Company gear like coffee mugs, T-shirts, phone chargers

Tip: Consider offering incentives to employees who are business travelers or work remotely.

# Planning a Vaccination Clinic for COVID-19 and Flu

If your company is already hosting a flu clinic this year, make it easier on you and your employees by expanding the event to include COVID-19 vaccinations. By turning your flu clinic into a combined COVID-19 and flu clinic, you could be providing more value to your employees and supporting the health of your workplace.

### COVID-19 & Flu Vaccinations

So, why should you offer COVID-19 vaccinations at your clinic? Coadministration is a common medical practice. Getting more than one vaccine at a time helps people get up-to-date on vaccinations all in one visit.<sup>16</sup>

- According to the CDC, eligible people may receive more than one vaccine during the same clinic visit<sup>14</sup>
- Employees can ask their healthcare provider or pharmacist about the risks and benefits of getting more than one vaccine in the same clinic visit

# Alternatives to Planning a Vaccination Clinic

Vaccination clinics may not be ideal for all companies, based on their size or number of remote workers. But there are alternatives to hosting an on-site clinic. Even without hosting your own clinic, you can still share the importance of employee health and vaccines to help your employees stay up-to-date on vaccinations.

# How to Spread the Word

Promote COVID-19 and flu vaccination(s) in the following ways:

- Emails to employees can highlight ways to schedule local vaccine appointments and link to resources, such as COVID-19 and flu facts
- Educational posters can be posted in break rooms, cafeterias, and other high-traffic areas
- Company intranet can be used to promote vaccinations
- Providing key facts about COVID-19 and flu through email or company intranet can help drive vaccine awareness and boost vaccination rates
- Distribute vaccination information (printed or PDFs) that employees can take home and share with their families



# Vouchers for COVID-19 and Flu Vaccination at Off-Site Clinics

Consider providing vouchers for all employees—including remote employees, those not covered by health insurance, or family members not covered by the employer benefits plan—so they can get vaccinated at a participating pharmacy

# If Possible, Consider Hosting a COVID-19 and Flu Vaccination Clinic

Helping your employees get vaccinated not only shows that their personal health is important to you, it also provides several big occupational health benefits to your business. This may include potential for<sup>12</sup>:

- Reduced absences due to sickness and doctors visits
- Reduced cost due to fewer absences, resulting in improved productivity
- Improved morale due to lack of absences and less individual workload

Plus, vaccinations are often already covered under employee health plans.<sup>15</sup>

### 10-Point Checklist: In Detail

### Help defend against flu and COVID-19 in one on-site clinic

- Consider offering COVID-19 and flu vaccinations at your on-site clinic. Giving more than one vaccine during a visit is called coadministration<sup>16</sup>

### Enlist a professional provider of vaccination services

- Here is a list of retail pharmacies providing on-site vaccination clinics nationwide that may be able to partner with you to host a clinic.<sup>17</sup> Although most pharmacies do not require minimum participation, some do. If you cannot meet the minimum, ask about locating your event at the nearest store. You can also work with other types of private companies
- The role of vaccination provider is to manage all aspects of vaccine administration. These include on-site set-up, appointment scheduling (if needed), clinical and support staffing, check-in, immunization, observation, reporting, and other standard requirements

# Choose a vaccination supervisor(s) for your company

Define clear roles and responsibilities for them. While anyone capable can take on this critical role, occupational health personnel or workplace safety staff may lead these efforts

# Pick a date: Fall may be the best time for your vaccination clinic

- Schedule clinics that last at least 2 days with multiple shifts
- Plan clinics after mid-September to ensure inventory is available for COVID-19 and flu vaccines
- Flu season usually begins in the fall, so consider hosting your vaccination clinic before the end of October<sup>18</sup>

### Ensure you have enough vaccine doses on-site

- Work with your pharmacy partner to ensure you have enough vaccine doses available
- Have employees sign up for specific time slots to facilitate schedules and encourage participation

### **Give employees a time slot to get their vaccinations**

- Ask managers and supervisors to allow employees to attend your on-site vaccination clinic as part of their workday and without having to take time off or making up for it after normal business hours
- Ensure consistent messaging about the upcoming clinic to encourage employees to incorporate it into their work schedule

### Consider offering vaccinations to employees' families

 Vaccinating employees and families can play an important role in helping protect the health of the communities where your business operates<sup>1</sup>
