## With Tivdak, I have a chance to tell my story.

People who were treated with Tivdak had a median overall survival of 11.5 months vs 9.5 months with chemotherapy. This was based on a study of 502 people with advanced cervical cancer who had received chemotherapy that did not work or is no longer working.\*

\*In the study, 253 patients received Tivdak, and 249 received chemotherapy.

## What is TIVDAK?

TIVDAK is a prescription medicine used to treat adults with cervical cancer:

- that has returned or has spread to other parts of the body, and
- who have received chemotherapy that did not work or is no longer working.

## Important Safety Information

### What is the most important information I should know about TIVDAK?

**Eye problems** are common with TIVDAK and can be severe. TIVDAK can cause changes to the surface of your eye that can lead to dry eyes, eye redness, eye irritation, corneal ulcers, blurred vision, and severe vision loss. **Tell your healthcare provider if you develop new or worsening vision changes or eye problems during treatment.**

### What is the most important information I should know about TIVDAK? (cont'd)

Your healthcare provider will prescribe 3 different types of eye drops before you start treatment with TIVDAK. **Bring the eye drops with you to each infusion and use them as directed by your healthcare provider to reduce your risk of eye problems:** 

- Use 1 drop of steroid eye drops in each eye before each infusion and continue to use your eye drops 3 times a day for 3 days after each infusion
- Use vasoconstrictor eye drops right before each infusion
- Use lubricating eye drops throughout treatment and for 30 days after your last dose of TIVDAK

**Do not** wear contact lenses throughout your treatment with TIVDAK unless you are told to use them by your eye specialist.

## What are the possible side effects of TIVDAK?

### Serious side effects of TIVDAK may include:

**Eye problems.** See "What is the most important information I should know about TIVDAK?"

**Nerve problems (peripheral neuropathy)** are common with TIVDAK and can be serious. Tell your healthcare provider right away if you have new or worsening numbness or tingling in your hands or feet or muscle weakness.

**Bleeding problems (hemorrhage)** are common with TIVDAK and can be serious. Tell your healthcare provider or get medical help right away if you have signs or symptoms of bleeding during treatment with TIVDAK, including blood in your stools or black stools (looks like tar), blood in your urine, cough up or vomit blood, unusual vaginal bleeding, or any unusual or heavy bleeding. **Lung problems.** TIVDAK may cause severe or life-threatening inflammation of the lungs that can lead to death. Tell your healthcare provider right away if you have new or worsening symptoms, including trouble breathing, shortness of breath, or cough.

**Severe skin reactions.** TIVDAK may cause severe or life-threatening skin reactions that can lead to death. Tell your healthcare provider or get medical help right away if you have signs or symptoms of a severe skin reaction during treatment with TIVDAK, including:

- Skin reactions that look like rings (target lesions)
- Rash or itching that continues to get worse
- Blistering or peeling of the skin
- Painful sores or ulcers in your mouth, nose, throat, or genital area
- Fever or flu-like symptoms
- Swollen lymph nodes

### The most common side effects of TIVDAK include:

- Decreased red blood cell

## Tell your healthcare provider about all your medical conditions, including if you: (cont'd)

have liver problems

- are pregnant or plan to become pregnant; TIVDAK can harm your unborn baby. Tell your healthcare provider right away if you become pregnant or think you may be pregnant during treatment with TIVDAK
- are breastfeeding (nursing) or plan to breastfeed. It is not known if TIVDAK passes into your breast milk. Do not breastfeed during treatment and for at least 3 weeks after the last dose of TIVDAK

### Females who can become pregnant:

- Your healthcare provider should do a pregnancy test before you start treatment with TIVDAK
- Use an effective method of birth control during your treatment and for at least 2 months after

the last dose of TIVDAK

## Males with female partners who can become pregnant:

• Use effective birth control during treatment and for 4 months after the last dose of TIVDAK

## So, **what** does it all mean?

When faced with a serious illness, you may hear your healthcare providers use words you are not familiar with. So, let's break them down.

**Recurrent** – A cancer that has come back after a period of time where it could not be detected

*Metastatic* – When a cancer has spread from where it started (primary site) to other places in the body

*Advanced cancer* – Another term for recurrent or metastatic cancer

*Median overall survival* – The amount of time half the people in a study group were still alive after treatment began In 16% of patients, cervical cancer has already spread to other parts of the body at diagnosis.

In up to 61% of women diagnosed with earlier stages of cervical cancer, the cancer will spread to other parts of the body within 2 years after initial treatment.

## / Living longer is possible

Tivdak was studied in a clinical trial of 502 people with cervical cancer that has returned or has spread, and who have received chemotherapy that did not work or is no longer working. In this trial, about half of the patients were treated with Tivdak (N=253), and about half of the patients were treated with chemotherapy (N=249). **One of the key results from the trial was overall survival (OS). Overall survival is the amount of time patients lived after the treatment began.**




## / With Tivdak, more people showed no signs of cancer or had their tumor shrink vs chemotherapy\*

The term **objective response** is another way to measure how effective a cancer treatment is. **This is a combination of partial response** (when a **tumor shrinks) or a complete response** (when there is no sign of cancer). Complete response doesn't mean the cancer has been cured, only that it cannot be measured or seen on a test.



## In the trial, **more people had a tumor response with Tivdak** vs chemotherapy

\*The Tivdak group had a complete response of 2.4% and a partial response of 15.4%. The chemotherapy group had a complete response of 0% and a partial response of 5.2%.

## / Tivdak is not like traditional chemotherapy

### Tivdak is the first treatment of its kind approved for advanced cervical cancer\*

Tivdak is unlike any medicine you have taken before for your cervical cancer. It is a different treatment called an antibody-drug conjugate, or ADC, which attacks cells that have a special protein called Tissue Factor. Tissue Factor is also present on some normal cells. So, Tivdak can still harm normal cells, which can cause side effects.

\*Advanced cervical cancer is cervical cancer that has returned or spread to other parts of the body while on or after anti-cancer therapy.

## / Possible side effects

Serious side effects of Tivdak may include eye problems, nerve problems (peripheral neuropathy), bleeding problems (hemorrhage), lung problems, and severe skin reactions. Tivdak can harm your unborn baby.

### The most common side effects of TIVDAK were:

- Decreased red blood cell counts
- Numbness or tingling in your hands or feet
- Eye problems (conjunctival disorders)
- Hair loss (alopecia)

• Bleeding (hemorrhage)

• Changes in liver function blood tests

• Tiredness

Nausea

Any of these things can begin to happen in the days following your infusion. A side effect does not necessarily mean you have to stop treatment. Your oncologist may need to adjust, pause, or stop your treatment if you have new or worsening side effects.

## Before starting Tivdak, tell your care team about any other medications you take

It's important to tell your care team about all the medicines you take, including prescription and over-the-counter medicines, vitamins, and herbal supplements. Taking Tivdak with certain other medicines may cause side effects. You should also let your other care teams know that you're starting treatment with Tivdak.



## / Starting & staying on Tivdak

One important part of starting and staying on treatment is Tivdak Required Eye Care. This is a set of steps you will follow that may help reduce the risk of eye problems.

## Before the infusion

### Visit your eye specialist

- Work with your care team to find an eye specialist to check your eyes before starting treatment. Similar exams will take place before each of your first 9 infusions of Tivdak and as needed. This is to check for any new or worsening signs or symptoms of eye problems
- Your eye specialist (either an optometrist or an ophthalmologist) will perform a visual acuity exam and a slit lamp exam

### Start your eye drop regimen

- Your doctor will prescribe 3 types of eye drops
- 1) Lubricating drops can be purchased over the counter
- 2) Steroid drops require a prescription
- 3) Vasoconstrictor drops require a prescription

## Bring all 3 eye drops

to each infusion appointment

## / Starting & staying on Tivdak

During the infusion (once every 3 weeks)

### Apply steroid drops and vasoconstrictor drops

• At the appointment, apply steroid drops (1 drop per eye) ten minutes before infusion, or as instructed. Apply vasoconstrictor drops (3 drops per eye) right before infusion, or as instructed

### Place a cold pack over the eye area

- Your care team will provide cold packs to place over the eye area during your infusion appointment. Each appointment includes about 1 hour of in-chair time
- Cold packs may help keep Tivdak from affecting your eyes by reducing blood flow in the eye

## After the infusion

### Apply steroid drops

- Apply steroid eye drops (1 drop per eye) two more times after your appointment on the day of your infusion
- On Days 2 and 3 following the infusion, apply steroid drops (1 drop per eye) three times per day, or as instructed by your care team

### Apply lubricating drops

• Use your lubricating drops daily throughout treatment and as needed, or as instructed by your care team

## Throughout treatment

- **Check your eyes daily** for new or worsening eye problems, including: dry eyes, eye redness, eye irritation, light sensitivity, blurred vision, or vision loss or impairment
- Avoid contact lenses and things that may irritate your eyes throughout treatment with Tivdak unless otherwise instructed by your care team

Tell your healthcare provider if you develop new or worsening vision changes or eye problems during treatment with Tivdak.
